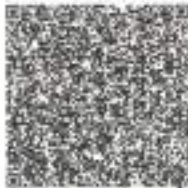

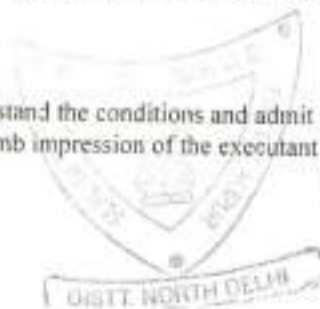

In continuation of the Supplementary Trust Deed registered by Sh Neeraj Chairman under the name '**RISHIKUL VIDYAPEETH EDUCATIONAL TRUST**' (Hereinafter referred to as '**THE SAID TRUST**') by virtue of Public Charitable Trust Deed dated 15/04/2015, duly registered as Registration No 710 in Addl. Book No. 4 Vol. No. 1,173 on Page 43 to 47, in the office of the Sub-Registrar-VI-B, New Delhi hereinafter referred to as '**SUPPLEMENTARY TRUST DEED**'

In continuation of the Supplementary Trust Deed registered by Sh Neeraj, Chairman (With all the rights of Settlor) under the name '**RISHIKUL VIDYAPEETH EDUCATIONAL TRUST**' (Hereinafter referred to as '**THE SAID TRUST**') by virtue of Public Charitable Trust Deed dated 06/03/2018, duly registered as Registration No 141 in Addl. Book No.4 Vol. No. 32, on Page 115 to 119, in the office of the Sub-Registrar-VI-E, New Delhi hereinafter referred to as '**SUPPLEMENTARY TRUST DEED**'.

AND WHEREAS subsequently in due compliance of the relevant provisions of the Principal Trust Deed, Sh Parth Sharma S/o Sh Neeraj R/o House No 407 Sector 14 Sonapat Haryana 131001 was inducted as New Trustees of the said Trust with unanimous consent of all the Trustees including the Chairman who also being one of the trustees of the said Trust.

AND WHEREAS Shri J P Sharma has expressed his desire to amend certain provisions of the Trust Deed particularly in view of his inability to continue as Trustees of the said Trust on account of his pre-occupation, to which the other Trustees have unanimously consented and agreed to.

Now in order to avoid any misunderstanding in future, it is desired to record into writing the amended provisions of the Principal Trust Deed.

NOW THIS AMENDMENT DEED WITNESSETH AS UNDER:-

1. That clause No. 10 (ix) of the Principal Trust Deed, shall be deemed to have been substituted by the following clause:-


"10. (ix) A Trustee may resign his office of the Trustee by communicating in writing his intention to resign from the Board of Trustees

The Governing body of the Trust shall consist of minimum 05 and maximum 11 members, with the following office bearers-

Chairman/ President	1
Managing Trustee/ (Secretary)	1
Executive Members	3

Sh Neeraj, will be the President/Chairman of the Governing Body until and unless he will resign from the presidentship by his own and in his absence Smt. Reema Sharma will be the President in the Governing Body's meeting. Further Smt. Reema Sharma, Managing Trustee will be the secretary of the Governing Body unless she will resign from the Secretaryship by her own and in her absence Mr Parth Sharma will be the Secretary in the Governing Body's Meeting. Mr. Neeraj, Mr Parth Sharma and Smt. Reema Sharma will be the life time trustee of the trust and in case of his/her death, their legal heir(s) will take their position in the Trust.

3. 5 of the Principal Trust Deed, shall be deemed to have been substituted by the

15. **AMENDMENTS/ ALTERATION:**

4. That Shri J P Sharma shall immediately after execution of this Amendment Deed shall be deemed to have resigned from the Trusteeship of the said Trust and shall have no right, title or interest in the said Trust/its activities/ assets etc. Further, Shri J P Sharma his legal heirs, successors neither at present have and nor shall in future claim any privilege/ rights/ options etc. in, to, upon or otherwise relating to said Trust and/or the other remaining Trustees. It is also clarified that all privileges, options as held by Shri J P Sharma as envisaged under the said Trust Deed shall be deemed to have been merged and extinguished forever in terms hereof.
5. That all other terms and conditions of the Principal Trust Deed along with previous supplementary deeds shall remain the same. This Amendment Deed shall form part and parcel of the all the previous Principal Trust Deed and Supplementary deeds .
